I am aware of and consent to the following: the collection of the data required by this application form and the taking of my photograph and, if applicable, the taking of fingerprints, are mandatory for the examination of the application; and any personal data concerning me which appear on the application form, as well as my fingerprints and my photograph will be supplied to the relevant authorities of the Member States and processed by those authorities, for the purposes of a decision on my application.

Such data as well as data concerning the decision taken on my application or a decision whether to annul, revoke or extend a visa issued will be entered into, and stored in the national Information System for a maximum period of five years, during which it will be accessible to the visa authorities and the authorities competent for carrying out checks on visas at external borders, immigration and asylum authorities for the purposes of verifying whether the conditions for the legal entry into, stay and residence on the territory are fulfilled, of identifying persons who do not or who no longer fulfil these conditions, of examining an asylum application and of determining responsibility for such examination. Under certain conditions the data will be also available to designated authorities of the Member States and to Europol for the purpose of the prevention, detection, and investigation of terrorist offences and of other serious criminal offences. I am aware that I have the right to obtain notification of the data relating to me recorded in the national information system, and to request that data relating to me, which are inaccurate, be corrected and that data relating to me processed unlawfully be deleted. I declare that to the best of my knowledge all particulars supplied by me are correct and complete. I am aware that any false statements will lead to my application being rejected or to the annulment of a visa already granted and may also render me liable to prosecution under the Luxembourg law.

I undertake to leave the territory of the Grand Duchy of Luxembourg before the expiry of the visa if granted and if applicable, in the absence of any other residence permit allowing me to reside there legally. I have been informed that possession of a visa is only one of the prerequisites for entry into the European territory and the Grand Duchy of Luxembourg. The mere fact that a visa has been granted does not mean that I will be entitled to compensation if I fail to comply with the relevant provisions of Article 6(1) of Regulation (EU) No 2016/399 (Schengen Borders Code) and I am therefore refused entry. The prerequisites for entry will be checked again on entry into the territory of the European Union's Member States under the above-mentioned provisions.
